rape and other forms of sexual violence have always been a feature of war yet it is only fairly recently that researchers have identified rape as a deliberate tool of war making rather than simply an inevitable side effect of armed conflict much of the emerging literature has suggested that the underlying causes of rape stem from a single motivation whether individual symbolic or strategic leading to disagreement in the field about how we can understand and respond to the causes and consequences of sexual violence in war in rape loot pillage sara meger argues that sexual violence is a form of gender based political violence perpetrated against both men and women and a manifestation of unequal gender relations that are exacerbated by the social political and economic conditions of war she looks at trends in the form and function of sexual violence in recent and ongoing conflicts to contend that in different contexts sexual violence takes different forms and is used in pursuit of different objectives for this reason no single framework for addressing conflict related sexual violence will be sufficient taking a political economy perspective meger maintains that these variations can be explained by broader struggles over territory assets and other productive resources that motivate contemporary armed conflicts sexual violence is a reflection of global political economic struggles and can t be addressed only at the local level it must be addressed through regional and international policy she concludes by providing some initial ideas about how this can be done via the un and national governments

the hunger report 1995 highlights progress during the past five years on the problems of food shortage poverty related hunger maternal child nutrition and health and micronutrient malnutrition it is constructed from papers and discussions presented at the five year follow up to the bellagio declaration overcoming hunger in the 1990s 1989 individual essays by hunger researchers monitors and policy makers assess advances in achieving the bellagio goals which are 1 to end famine deaths especially by moving food into zones of armed conflict 2 to end hunger in half the world s poorest households 3 to eliminate at least half the hunger of women and children by expanding maternal child health coverage and 4 to eliminate vitamin a and iodine deficiencies as public health problems

this book presents a systematic analysis of the notion of control in the law of military occupation the work demonstrates that in present day occupations control as such occurs in different forms and variations the polymorphic features of occupation can be seen in the way states establish control over territory either directly or indirectly and in the manner in which they retain relinquish or regain it the question as to what level and type of control is needed to determine the existence and ending of

stripes through terrorism war ethnic cleansing genocide and other forms of mass violence are also responsible for widespread cultural destruction as she demonstrates in this new book burning books and leveling libraries is structured in three parts part i is devoted to struggles by extremists over voice and power at the local level where destruction of books and libraries is employed as a tactic of political or ethnic protest part ii discusses the aftermath of power struggles in germany afghanistan and cambodia where the winners were utopians who purged libraries in efforts to purify their societies and maintain power part iii examines the fate of libraries when there is war and a resulting power vacuum the book concludes with a discussion of the events in iraq in 2003 and the responsibility of american war strategists for the widespread pillaging that ensued after the toppling of saddam hussein this case poignantly demonstrates the ease with which an oppressed people given the collapse of civil restraints may claim freedom as license for anarchy construing it as the right to prevail while ignoring its implicit mandate of social responsibility using military might to enforce ideals in this case democracy and freedom is futile knuth argues if insufficient consideration is given to humanitarian security and cultural concerns

this book explores the thirty year border conflict between

armenia and azerbaijan specifically around the former autonomous republic of nagorno karabakh and shows how russia is the only winner in this conflict fighting on both sides supplying arms to both sides and acting as the arbiter between the two sides the author looks at armenia azerbaijan and the separatists from military political economic and diplomatic perspectives and offers insights on how the fighting has influenced society and vice versa the book provides an update to the history of the war to include major fighting in 2020 and examines how russia obtained three military bases and most economic assets in armenia while becoming azerbaijan s major weapons supplier to the tune of six billion dollars it shows how russia has tried to sideline the internationally supported minsk negotiations in favor of russia assuming the sole role of arbiter and argues that even though russia has submitted a number of ceasefire proposals it does little to encourage the sides to implement them the book includes a discussion of international law united nations resolutions and rulings by the european court of human rights

rebel groups exhibit significant variation in their treatment of civilians with profound humanitarian consequences this dissertation proposes a new theory of rebel behavior and cohesion based on the internal dynamics of rebel groups rebel leaders have incentives to provide security but are often unable to prevent group members from abusing civilians leaders exert effective control over their troops when they can offer cash payments and credible future rewards to their top commanders leaders who cannot offer these incentives allow their forces to loot locals in exchange for a minimal level of loyalty the leader s ability to offer incentives that allow local security to prevail depends on partnerships with external actors such as diaspora communities and foreign governments when these patrons have a stake in the group's success they are motivated to supply financial resources to qualified trusted leaders other patrons have goals that conflict with those of the rebel client these patrons exert leverage over the rebels by supporting low quality leaders and withholding resources that could strengthen leader control resulting in more abusive faction prone groups the type of partnership available depends on factors beyond the group s control the dissertation formalizes this theory and tests the implications in various ways using an original cross national dataset of rebel groups 1980 2003 as well as a micro level dataset of crop area during liberia s war derived through remote sensing the dissertation also traces the model s logic through a detailed analysis of liberia s rebel groups based on fourteen months of fieldwork and interviews with nearly all surviving rebel leaders and top commanders who participated in liberia s war 1989 2003
