the routledge handbook on livelihoods in the global south presents a unique timely comprehensive overview of livelihoods in low and middle income countries since their widespread adoption in the 1990s livelihoods perspectives frameworks and methods have influenced diverse areas of research policy and practice the concept of livelihoods reflects the complexity of strategies and practices used by individuals households and communities to meet their needs and live their lives the handbook brings together insights and critical analysis from diverse approaches and experiences learning from research and practice over the last 30 years the handbook comprises an introductory section on key concepts and frameworks followed by five parts on researching livelihoods negotiating livelihoods generating livelihoods enabling livelihoods and contextualising livelihoods the introduction provides readers with an appreciation of concepts researched and applied in the five parts including chapters on vulnerability and resilience social capital and networks and institutions each part reflects the diversity of approaches taken to understanding livelihoods whilst recognising commonalities including the centrality of power in shaping enabling and constraining livelihoods the book also reflects diversity of context including conflict climate change and religion as well as in generating livelihoods through agriculture small scale mining and pastoralism the aim of each chapter is to provide a critically informed introduction and overview of key concepts issues and debates of relevance to the topic with each chapter concluding with suggestions for further reading it will be an essential resource to students researchers and practitioners of international development and related fields researchers and practitioners will also benefit from the book s diverse disciplinary contributions and by the wide and contemporary coverage

the shifting nature of employment practice towards the use of more precarious work forms has caused a crisis in classical labour law and engendered a new wave of regulation this timely book deftly uses this crisis as an opportunity to explore the notion of precariousness or vulnerability in employment relationships arguing that the idea of vulnerability has been under theorised in the labour law literature lisa rodgers illustrates how this extends to the design of regulation for precarious work the book s logical structure situates vulnerability in its developmental context before moving on to examine the goals of the regulation of labour law for vulnerability its current status in the law and case studies of vulnerability such as temporary agency work and domestic work these threads are astutely drawn together to show the need for a shift in focus towards workers as vulnerable subjects in all their complexity in order to better inform labour law policy and practice more generally constructively critical labour law vulnerability and



the regulation of precarious work will prove invaluable to students and scholars of labour and employment law at local eu and international levels with its challenge to orthodox thinking and proposals for the improvement of the regulation of labour law labour law institutions will also find this book of great interest and value

this book provides the first systematic account of the premium costs that migrants pay to live and work abroad reducing the costs of international labour migration specifically worker paid costs for low skilled employment has become an important item on the global agenda over the last years and is particularly pertinent for the un s global compact on safe orderly and regular migration recruitment costs alone amount in most migration corridors to anywhere between one and ten months of foreign earnings and many migrants may well lose between one and two years of foreign earnings if all costs are considered this book is intended as a primer for evidence based policy for reducing the costs of international labour mobility the contributors include academics from law economics and politics but also authors from international organizations non governmental organizations as well as the voices of migrants the hope of the editors is that this small collection sets the basis for evidence based policies that seek to reduce the costs of international migration this book will be of interest to scholars and students of migration globalization law sociology and international relations as well as practitioners and policy makers

negotiating citizenship explores the growing inequalities associated with nation based citizenship from the perspective of migrant women workers who have made their way from impoverished third world countries to work in canada in the caregiving industries of domestic service and nursing the study demonstrates the impact of the global political economy public and private gatekeeping mechanisms and racialized and gendered stereotypes on the contested relationship between citizen employers and non citizen female migrant workers in canada

in a remarkable pairing two renowned social critics offer a groundbreaking anthology that examines the unexplored consequences of globalization on the lives of women worldwide women are moving around the globe as never before but for every female executive racking up frequent flier miles there are multitudes of women whose journeys go unnoticed each year millions leave mexico sri lanka the philippines and other third world countries to work in the homes nurseries and brothels of the first world this broad scale transfer of labor associated with women s traditional roles results in an odd displacement in the new global calculus the female energy that flows to wealthy countries is subtracted from poor ones often to the detriment of the families left behind the migrant nanny or cleaning woman nursing care attendant maid eases a care deficit in rich countries while her absence creates a care deficit back home confronting a range of topics from the fate of vietnamese mail order brides to the importation of mexican nannies in los angeles and the selling of thai girls to japanese brothels global woman offers an unprecedented look at a world shaped by mass migration and economic exchange on an ever increasing scale in fifteen vivid essays of which only four have been previously published by a diverse and distinguished group of writers collected and introduced by bestselling authors barbara ehrenreich and arlie russell hochschild this important anthology reveals a new era in which the main resource extracted from the third world is no longer gold or silver but love

she theorizes two bases of the black scare red scare us capitalist racist society a racially hierarchical political economy built on exploitative labor relationships and wall street imperialism the violent processes by which businesses and the us government structured domestic and foreign policies to consolidate capital and racial domination in opposition radical blackness embodied the government s fear of both black insurrection and red instigation the state s actions and rhetoric therefore characterized black anticapitalists as foreign alien and undesirable this reactionary response led to an ideology that burden stelly calls true americanism the belief that the best things about america were absolutely not red and not black which were interchangeable threats black scare red scare illuminates the anticomunist nature of the us and its governance but also shines a light on a misunderstood tradition of struggle for black liberation

there is no threat to western democracies today comparable to the rise of right wing populism while it has played an increasing role at least since the 1990s only the social consequences of the global financial crises in 2008 have given it its break that led to uk s brexit and the election of donald trump as us president in 2016 as well as promoting what has been called left populism in countries that were hit the hardest by both the banking crisis and consequential neo liberal austerity politics in the eu such as greece and portugal in 2017 the french front national fn attracted many voters in the french presidential elections we have seen the radicalization of the alternative für deutschland afD in germany and the formation of centre right government in austria further we have witnessed the consolidation of autocratic regimes as in the eu member states poland and greece all these manifestations of right wing populism share a common feature they attack or even compromise the core elements of democratic societies such as the separation of powers protection of minorities or the rule of law despite a broad debate on the re emergence of populism in the transition from the twentieth to the twenty first century that has brought forth many interesting findings a lack of sociological reasoning cannot be denied as sociology itself withdrew from theorising populism decades ago and largely left the field to political sciences and history in a sense populism and the crisis of democracy considers itself a contribution to begin filling this lacuna written in a direct and clear style this set of volumes will be an invaluable reference for students and scholars in the field of political theory political sociology and european studies this volume concepts and theory offers new and fresh perspectives on the debate on populism starting from complaints about the problems of conceptualising populism that in recent years have begun to revolve around themselves the chapters offer a fundamental critique of the term and concept of populism theoretically inspired typologies

we live at a time when the human lifespan has increased like never before as average lifespans stretch to new lengths what impact should this have on our values should our values change over the course of our ever increasing lifespans nancy s jecker coins the term the life stage relativity of values to capture the idea that at different stages of our lives different ethical concerns shift to the foreground during early life infants and small children hold dear the value of being cared for and nurtured by someone they trust and their vulnerability and dependency make these the right values for them by early adulthood and continuing into midlife the capacity for greater physical and emotional independence gives people reason to place more emphasis on autonomy and the ability to freely choose and carry out their plan of life during old age heightened risk for chronic disease and disability gives us a reason to shift our focus again emphasizing safeguarding our central capabilities and keeping our dignity and self respect intact despite different values becoming central at different stages of life we often assume the standpoint of someone in midlife who is in the midst of planning a future adulthood that stretches out before them jecker coins the term midlife bias to refer to the privileging of midlife midlife bias occurs when we assume that autonomy should be our central aim at all life stages and give it priority in a wide range of ethical decisions the privileging of midlife raises fundamental problems of fairness it also suggests the possibility of large gaps in the ethical principles and theories at hand ending midlife bias new values for old age addresses these concerns in a step

wise fashion focusing on later life jecker first introduces a philosophical framework that extends moral theorizing to older adults addressing midlife bias the life stage relativity of values human capabilities and dignity time s passage the narrative self and justice between old and young she then turns to policy and practice and explores ethical issues in bioethics long term care personal robotic assistants care of the dying and newly dead ageism in medical research the allocation of healthcare mandatory retirement and the future of population aging

prevent and punish such conduct in between immunity and impunity yuliya zabyelina unravels the intricate layers of impunity of political elites complicit in transnational crimes by examining cases of trafficking in persons and drugs corruption and money laundering that implicate heads of state and of government ministers diplomats and international civil servants she shows that despite the potential of international law immunity to impede or delay justice there are prominent instruments of external accountability accessible and compelling this book provides novel insights for readers interested in the close knit bond between power illicit wealth and impunity
