drawing on insights from literary theory and analytical philosophy this book analyzes the intersection of law and literature from the distinct and unique perspective of fictional discourse pursuing an empirical approach and using examples that range from victorian literature to the current judicial treatment of rap music the volume challenges the prevailing fact fiction dichotomy in legal theory and practice by providing a better understanding of the peculiarities of legal fictionality while also contributing further material to fictional theory s endeavor to find a transdisciplinary valid criterion for a definition of fictional discourse following the basic presumptions of the early law as literature movement past approaches have mainly focused on textuality and narrativity as the common denominators of law and literature and have largely ignored the topic of fictionality this volume provides a much needed analysis of this gap the book will be of interest to scholars of legal theory jurisprudence and legal writing along with literature scholars and students of literature and the humanities

vivid prose plunges the reader into the politically fraught self contained world of a military base and a chilling true case of triple murder linda landrigan editor of alfred hitchcock mystery magazine carlton butch smith was a troubled teenager who d been kicked out of school for aggressive behavior his parents lived at marine corps base camp lejeune in jacksonville north carolina and when butch was home with them his life was fairly normal but that all changed on august 24 1981 when butch s sister aunt and cousin were found slain in his parents house it was a horrifying crime that shook the marine base community not to mention the smith family especially when butch was named the prime suspect in tunnel vision reporter and true crime author n p simpson delves into this young man s harrowing past she also provides a detailed chronicle of the grisly murders and the complex case that followed a case of conflicting confessions a mysterious second suspect who was never found and difficult questions of jurisdiction between military state and federal courts

this book exposes the myriad of victims of wrongful conviction by going beyond the innocent person who has been wrongfully incarcerated to include the numerous indirect victims who suffer collaterally in no way overlooking the egregious effects on the wrongfully convicted this book widens the net to also examine consequences for family friends co workers witnesses the initial victims of the crime and society in general all indirect victims who are often forgotten in treatments of wrongful conviction utilizing interviews of exonerees and indirect victims the authors capture the tangible and intangible costs of victimization across the board the prison experience is examined through the lens of an innocent person and the psychological impact of incarceration for the exoneree is explored special attention is given to the often ignored experience of female exonerees and to the impact of race as a compounding factor in a vast number of miscarriages of justice the book concludes with an overview of the victimization experiences that follow exonerees upon release unique to this book is its interdisciplinary approach to the troubling subject of wrongful conviction combining perspectives from a number of fields including criminal justice criminology victimology psychology sociology social justice history political science and law undergraduate and graduate students in these disciplines will find this book helpful in their respective areas of study and professionals in the legal system will benefit from appreciation of the far reaching costs of wrongful convictions

read him his rights we all recognize this line from cop dramas but what happens afterward in this book richard leo sheds light on a little known corner of our criminal justice system the police interrogation incriminating statements are necessary to solve crimes but suspects almost never have reason to provide them therefore as leo shows crime units have developed sophisticated interrogation methods that rely on persuasion manipulation and deception to move a subject from denial to admission serving to shore up the case against him ostensibly aimed at uncovering truth the structure of interrogation requires that officers act as an arm of the prosecution skillful and fair interrogation allows authorities to capture criminals and deter future crime but leo draws on extensive research to argue that confessions are inherently suspect and that coercive interrogation has led to false confession and wrongful conviction he looks

at police evidence in the court the nature and disappearance of the brutal third degree the reforms of the mid twentieth century and how police can persuade suspects to waive their miranda rights an important study of the criminal justice system police interrogation and american justice raises unsettling questions how should police be permitted to interrogate when society needs both crime control and due process how can order be maintained yet justice served

how states are making their legal systems more equitable seen through the story of a black man falsely imprisoned for thirty years for murder in 1987 ben spencer a twenty two year old black man from dallas was convicted of murdering white businessman jeffrey young a crime he didn t commit from the day of his arrest spencer insisted that it was an awful mistake the texas legal system didn t see it that way it allowed shoddy police work paid witnesses and prosecutorial misconduct to convict spencer of murder and it ignored later efforts to correct this error the state s bureaucratic intransigence caused spencer to spend more than half his life in prison eventually independent investigators new witness testimony the foreman of the jury that convicted him and a new dallas da convinced a texas judge that spencer had nothing to do with the killing and in 2021 he was released from prison as spencer s fight to clear himself demonstrates our legal systems are broken expedience is more important than the truth that is starting to change as states across the country implement new efforts to reduce wrongful convictions and one of the states leading the way is texas award winning journalist barbara bradley hagerty has spent years digging into this issue and she has immersed herself in spencer s case she has combed police files and court records interviewed dozens of witnesses and had extensive conversations with spencer and in bringing ben home she threads together two narratives how an innocent black man got caught up in and couldn t escape a legal system that refused to admit its mistakes and what texas and other states are doing to address wrongful convictions to make the legal process more equitable for everyone by turns fascinating and enraging personal and provocative bringing ben home is the powerful story of one innocent man who refused to admit that he was guilty of murder and how his plight became part of a paradigm shift in how the legal system thinks about innocence as it institutes new methods to overturn wrongful convictions to better protect people like ben spencer
